SUBJECT: Movement Directive, RO Group K920-14RO (AIR).

TO : Personnel concerned.

1. The individuals listed in attached personnel roster are assigned for movement to RO Group K920-14RO (AIR).
2. Group K920-14RO will move on or about 5 July 1945 from present overseas station to a reception station in the US to be named by indorsement to this order by the Commander of the US port at which the group is debarked.
3. Capt George A. Barnes is designated commander of Group K920-14RO at all times during the entire movement from present overseas station to the reception station in the US.
4. This movement constitutes a permanent change of station for each individual, with temporary duty enroute at a US port, reception station, and redistribution station. The latter will designate the new permanent station of each individual.
5. Group K920-14RO will be under the control of the CG, ASF, from time of departure from overseas station until released by proper auth in the US.
6. Information concerning the War Department, army or personal activities of a military nature within this theater will not be discussed in private or public and will not be disclosed by means of newspapers, magazines, books, lectures or radio, or any other method without prior clearance through the WD Bureau of Public Relations or the appropriate Public Relations Officers of Army installations.
7. Per diem is authorized the individual in this movement within allowance stated by law.
