The fol Os, 2d Emerg Rescue Sq, APO 719 WP at proper time to APOs 927, 923, 922 and ret on TDY in connection w/AF activities: In lieu of subs, flat per diem of \$6.00 is auth for tvl, necessary delay enroute and periods of TDY. If govt billets furnished, deduct \$3.75; if govt messing facilities utilized, deduct \$.75 per meal. TC will furnish necessary transportation. TDN. Tvl by mil, commercial acft (Par 3b AR 55-120), rail, govt mtr and water transportation auth. Personal baggage not to exceed 50 pounds auth while traveling by air. All per diem suspended outside continental limits of Australia. Total period of tvl and TDY not to exceed seven (7) days. FD 65-*** P 432-02 03 A212/50425. CIPAP

2. T Sgt Raymond H. Hundley, 17014705, 2d Emerg Rescue Sq, APO 719 WP at proper time to APOs 927, 923, 922 and ret on TDY in connection w/AF activities. TC will furnish necessary transportation. TDN. Tvl by mil, commercial acft (Par 3b AR 55-120), rail, govt mtr and water transportation auth. Personal baggage not to exceed 50 pounds auth while traveling by air. Per diem of \$5.00 auth during periods of tvl by air and TDY within Australia. From total per diem so computed deduct \$.75 for each meal that govt messing facilities are available and \$2.75 for each day that govt qrs are available. If tvl is performed other than by air or water, monetary alws in lieu of rat and qrs is auth as follows during periods of tvl and TDY: \$5.00 when neither govt qrs or messing facilities are available: \$3.00 when govt qrs but no messing facilities are available: \$2.00 when govt messing facilities but no qrs are available. No per diem or alws auth outside Australia, or while traveling by water. Use of available govt messing facilities and qrs is mandatory. Total period of tvl and TDY not to exceed seven (7) days.
